2018 – 2019 GENERAL LIABILITY INSURANCE

Paczolt Insurance Alliance continues to provide P of A members General Liability protection for the performing company or regional puppet guilds from bodily injury or property damage claims to third parties while performing or assembling at various venues. This policy does NOT provide coverage to participants.

General Liability insurance is required by most venues. The coverage is for 1M per occurrence of liability insurance, with an aggregate of 2M. Medical Expense coverage is 5K (per person). Product/Completed Operations is 1M. Advertising/Personal Injury is 1M, and Damage to Rented Premises is 100K (each occurrence). There is no deductible.

The policy term runs annually from **October 6, 2018 to October 5, 2019**. This year’s premium, for members of the Puppeteers of America, is \$340.00. This cost includes all certificates and additional insured endorsements when requested. The cost remains the same regardless of when you join. ***Membership contact information is listed below.**
